

Invitation to Bid



The **CAGAYAN STATE UNIVERSITY** through the *External Fund* intends to apply the sum of **One Million Four Hundred Ninety Nine Thousand Five Hundred Fifty Three Pesos and 38/100 (P 1,499,553.38)**, being the Approved Budget for the Contract (ABC) to payments under the contract for **“CONSTRUCTION OF 4 UNITS SAWTOOTH GREENHOUSE STRUCTURE (PROJ.REF.NO: CSU2019-09-0600)”**.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The **CAGAYAN STATE UNIVERSITY** now invites bids for the following:

Items to be bid are offered as Five Hundred Seventy Six (576 square meter), and the basis shall be the offer or bid for the entire square meter covering all the work items required to complete the project. Incomplete bid shall be rejected.

2. Completion of the Works is within 35 calendar days. Bidders should have completed, within thirty five (35) calendar days from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in SECTION II. INSTRUCTION TO BIDDERS.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, whose business is registered in Region 2.

4. Interested bidders may obtain further information from **CAGAYAN STATE UNIVERSITY** at the address given below from Monday to Friday, 8:00 AM-5:00PM, beginning **October 2** until **October 18, 2019**. Release of Bidding Documents shall commence **October 18, 2019**.

Copy of Bidding Documents may be downloaded free of charge from the website of the

Philippine Government Electronic Procurement System (PhilGEPS) and the website of CSU (<http://gonzaga.csu.edu.ph>). The BAC will also issue hard copies of the BDs at the address given below to eligible bidders upon payment of a non-refundable fee of **PhP 5,000.00**. Bidders that will download the BDs shall pay the said fee upon the submission of their bids.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The **CAGAYAN STATE UNIVERSITY** will hold a Pre-Bid Conference on **October 18, 2019** (9:00 a.m.) at the Conference Room, CSU-Gonzaga Campus which shall be open to prospective bidders.
6. Bids must be duly received by the BAC Secretariat at the address below on or before **November 04, 2019 (9:00 a.m.)**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **November 04, 2019, at exactly 10:00 AM** at CSU-Gonzaga Conference Room. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. **LATE BIDS SHALL NOT BE ACCEPTED.**
7. The **CAGAYAN STATE UNIVERSITY** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
